A 4-day/4-night post-tour "Amazon Rainforest" option is available for \$1,195 total price (single travelers please add \$235; land only travelers: \$1,295 total price). *Please note: This trip involves considerable walking uphill, on uneven terrain, and at sites of ancient ruins. You should be in good physical condition to enjoy the tour to the fullest. In addition, the high altitude of Lake Titicaca (12,500 feet) and Cuzco (11,150 feet) could pose problems for travelers with certain health conditions. Please consult your physician if you have concerns.*

***PLEASE NOTE:** At this time, elements of the tour are still being finalized. Your deposit will be fully refundable until all details, including pricing, are complete. Our tour operator, Odysseys Unlimited, Inc., will be in touch with you in December 2018 when the final tour details and tour brochure are available.
